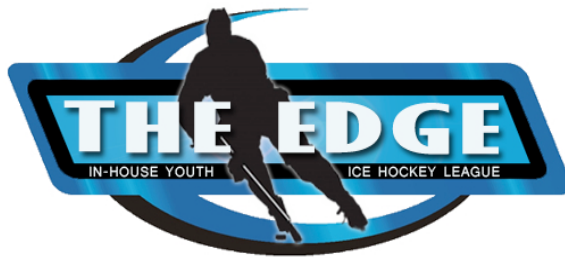

I/we understand and voluntarily agree that all elected or duly appointed officials of the program are to be deemed to have assumed an office or assignment with the express understanding and condition that each of them, their heirs, executors and administrators, estate and effects shall at all times be saved harmless from and against said parties for and in the execution of their duties pertaining to the activities of the above organization. The EDGE Ice Hockey League is not responsible for loss or damage to any personal property.
5. Full equipment is required for games, drop-ins, stick-time, clinics and camps. NO EXCEPTIONS.
6. Teams may be combined together if a minimum of fifteen players per team is not achieved. Each team will have an average of fifteen (15) players, plus goalie and a standby waiting list.
